1. How to proceed with the Koiwa Junior High School PTA

Chapter 1 Names

Article 1 This association shall be called the Edogawa Ward Koiwa Third Junior High School PTA, and the office shall be located in Koiwa Third Junior High School.

Chapter 2 Objectives

Article 2 The Association will strive for friendship and training among members, cooperate with the development of Koiwa Third Junior High School, and provide welfare to students.

Strive to improve.

Chapter 3 Activity Policy

Article 3 The Association shall act democratically and voluntarily with the purpose of education.

Article 4 The Association does not support or interfere with any commercial, religious, or political party activities.

Article 5 The Association shall cooperate with other organizations that work for the welfare of children, students, and adolescents.

Article 6 The Association shall not interfere with the management of the school or the personnel of teachers.

Article 7 The Association shall not be immediately responsible for the school's finances, teachers' salaries, etc.

Chapter 4 Members

Article 8 The members of the Association shall be the parents and faculty members of students enrolled in Koiwa No. 3 Junior High School.

Those who live in the school district and are particularly interested in education are required to obtain the approval of the executive committee and be a member of the

It can be.

Chapter 5 Accounting

Article 9 The expenses of the Association shall be covered by membership fees and other expenses.

Article 10 The property of the Association shall be used for the purposes of Chapter 2.

Article 11 The accounting of the Association shall be audited once a year.

Article 12 The fiscal year of the Association shall begin on April 1 of each year and end

on March 31 of the following year.

Chapter 6 Officers and Advisors

Article 13 The following officers shall be appointed to the Association:

1. The composition of the officers is the chairman (P1), the vice president (a few P, T1 vice principal),

The treasurer (P, T1) and the secretary (P, T1).

2. The term of office of the new officer shall be one year, and he may be reappointed.

Article 14 The election and inauguration of officers are as follows.

1. The Executive Recommendation Committee recommends candidates from among the members by the Executive Committee in March and approves them by the Executive Committee.

After that, all members will be notified. At the request of the recommendation committee, each chairperson may cooperate.

2. Officers will be elected from among the executive candidates at the March Executive Committee. However, the officers of the faculty and staff will be in the new school year

The principal recommends it.

3. The new officer will be appointed on April 1.

4. When there is a shortage of new officers, if a candidate is elected after April 1 or before the establishment of the recommendation committee,

You may take office with the approval of the board of directors.

Article 15 The duties of the officers are as follows:

1. The president shall represent the association, oversee the affairs of the association, and preside over the general meeting and the executive committee. It also approves the chairman of all committees. However, excluding the Officer Candidate Recommendation Committee and the Accounting Audit.

2. The vice president shall assist the president and act on his behalf when the president is unable to perform his duties.

3. The clerk handles all affairs except accounting.

4. The treasurer accurately records the financial income and expenditure of the association and reports it at each general meeting. In addition, at the general meeting in May, the financial report of the previous year will be submitted and approved for approval.

Article 16 The Association shall have an advisor. (Former Chairman)

Chapter 7 Assemblies

Article 17 1. The General Assembly shall be the highest decision-making body of the Association, and shall be the Regular General Assembly and the Extraordinary General Meeting.

2. The General Assembly shall be established by a majority of the members. In addition, members can submit a power of attorney in lieu of attendance.

Article 18 In principle, the regular general meeting shall be held once a year, and shall be deliberated by convocation or written deliberation.

Deliberation and decision will be made including the following contents.

General Meeting (b) Approval of officers and accounting audit for the new fiscal year (b) Financial report (c) Activity report

2. Activity Plan E, Budget Proposal C, Introduction of the Executive Committee

Article 19 The Extraordinary General Meeting may be convened and held on an extraordinary basis when the Executive Committee deems it necessary or when more than one-fifth of the members request it.

Article 20 The resolution of the general meeting shall be decided by a majority of the attendees.

Article 21 The Executive Committee shall be the executive body of the Association's affairs composed of officers, the chairman of each standing committee, the vice-chairperson, or a person equivalent to the person appointed thereto, and shall be the decision-making body next to the General Assembly.

Article 22 The Executive Committee shall meet once a month in principle, and its duties are as follows:

1. Deliberation of proposals and activity plans submitted by various committees
2. Preparation of budget proposals
3. Preparation of documents to be submitted to the general meeting
4. Establishment of a special committee
5. Deliberation of contingent affairs

Article 23 The General Committee shall be held at any time as necessary.

Article 24 The Officer Candidate Recommendation Committee shall consist of a total of 15 members, including 9 members from the Standing Committee, 3 from the Standing Committee, and 3 from the School in April of each year. If a standing committee is not established, an officer will act on his behalf.

Article 25 The committee shall be a standing committee or a special committee, and shall be held at any time as necessary. The standing committee shall be the Adult Committee, the Public Relations Committee, and the Off-campus Committee. The Special Committee may establish a special committee with the approval of the Graduation Committee, the Executive Recommendation Committee, and the Executive Committee if necessary for operation.

Article 26 The standing committee shall be divided between parents and teachers elected from the adult committee, public relations committee, and off-campus committee.

The chairman and vice-chairman of each committee shall be elected. The graduation committee of the special committee is selected from the parents of the third grade.

Article 27 The planning and operation of various committees require the approval of the Executive Committee.

Article 28 The principal may attend the general meeting and committee meeting as a representative of the school.

Chapter 8 Provisions

Article 29 These Articles of Association shall come into effect on July 20, Reiwa 3, and

such amendments and abolitions shall be made with the approval of the General Assembly.
Article 30 If it is necessary for the smooth execution of the affairs of the Association,
the President may establish separate rules with the approval of the Executive
Committee.

PTA Membership Fee Regulations

Date of enactment: November 1, 4th year of Reiwa

(Purpose)

第1条 These bylaws specifically stipulate the matters necessary for the smooth implementation of procedures related to PTA membership fees.

(Collection method)

第2条 The method of collecting PTA membership fees is as follows.

- (1) In order to handle cash and prevent non-payment of membership fees, we will use an automatic debit account for school lunch expenses, etc.
- (2) In order to protect the personal information of members, the management of the account will be handled by the school administration.
- (3) Regarding the settlement of membership fees related to moving in and out, non-payment of membership fees, etc., the school office and the PTA will work together to deal with this.

(Membership Fee)

第3条 PTA membership fees are as follows.

- (1) Parents are enrolled in 4,000 yen per year for each student
- (2) 4,000 yen per faculty member per year

(Membership Fees for Moving In)

第4条 The membership fees for moving in and out are as follows.

- (1) It will be calculated on a monthly basis of 400 yen per month. However, in consideration of school events, the monthly fee will be 0 yen in August and March. The specific monthly amount is shown in Table 1.
- (2) The month in which you move in and out is 400 yen per month, excluding August and March, based on the preceding paragraph. The specific annual membership fee at the time of moving in is shown in Table 2, and the refund at the time of moving out is shown in Table 3.

- (1) Marriage 5,000 yen

 - (2) Spouse 5,000 yen
 - (3) Children and parents (real) 5,000 yen
 - (4) Sympathy (the person) (Consult with the board of directors during official duties)
 - (1) Hospitalization (more than 1 week) 5,000 yen
 - (2) Sick leave (more than 1 month) 5,000 yen
 - (5) Transfer and retirement
 - (1) Principal and Vice-Principal *10,000 yen + (1,500 yen × number of years of employment)
 - (2) PTA teachers * 5,000 yen + (1,500 yen × number of years of employment)
 - (3) Other teachers * 1,500 yen × number of years of employment (minimum 2,000 yen)

- (6) Disasters Consult with the board of directors.

3. Others

- (1) Local meritorious persons, PTAs, alumni, etc. shall consult with the board of directors each time.
(Scope: Excluding graduates, former officers, executive committee members, etc.)
- (2) Others Consult with the Executive Committee.
